EAST SIDE LEARNING CENTER (ESLC) ENVISIONS A COMMUNITY IN WHICH "ALL CHILDREN READ WITH PRIDE AND JOY TO BECOME LIFE-LONG LEARNERS." ESLC BRINGS TOGETHER COMMUNITY ELDER, TEACHERS AND PARENTS TO SUPPORT STRUGGLING READERS IN ITS LITERACY MENTORING (K-3RD GRADE) TUTORING PROGRAM DURING OR AFTER SCHOOL AND SUMMER SCHOOL.

DURING THE 2023-2024 SCHOOL YEAR, 156 CHILDREN PARTNERED WITH 79 CARING ADULT LITERACY MENTOR TUTORS IN 2 TO 4 SESSIONS PER WEEK.
